- From last year - New Educational Neglect Pleadings – already in effect

BIG NEWS – ALBANY WAS HOT !!! - LOTS of bills in child welfare have passed – they will now go to Gov’r to see if signed into law, vetoed or chapter amendments!

A 2199A/S4203A – Post TPR visitation

A 8060A/ S6427A - Indications and SCR retentions

A7974/S6215 – Notice of changes in placement

A7941/S.6472 – Re-entry into Care

- A8059/S6405 – “Relative” definition in foster parent hearings FCA 1028-a hearings
- A 5494/S 3419 – Adoptees right to BC
- A4784C/S.2836C – Marie’s Law re restrictions on sex offenders for custody and visitation - signed into law Chapt 182. eff 9/21/19
- A569/S2714 – written info to relatives on options
- A2106A/S5024A – Mandate for DSS/ACS to file TPR can be excused by parents in deportation proceedings
- A2006/S1506 – Immigration and TPRs – signed into law Chapt 56, eff 10/27/19
- PLUS – Be Aware of LOTS of new bills in JD and PINS area – including of course the PINs changes in the budget bill and A.7940/S.6535 – JD/PINS Permanency Bill - some DV, child support changes –
